Proceedings of the Arlington Historical Society 1964 - 1965

Meeting of September 11, 1964

The Society met at Gunston Hall, the colonial home of George Mason.

The President announced that the Finance Committee had submitted plans for custody of the Endowment Fund and read a letter of recommendation prepared by L. L. Ecker-Racz. The recommendations were accepted by the Board of Directors. A sum of \$1,600.00 was reported as having been donated to this fund.

Finances of the Society as of Sept. 8, 1964, were \$451.00 in the Operating Account, \$1,210.00 in the Savings Account, and \$1,600.00 in the Endowment Fund.

It was announced that the Hume School Historical Museum now has a permanent identification sign on the front of the building.

Mr. Douglass R. Hayes was elected to fill the vacancy on the Board of Directors created by the death of Percy C. Smith.

Membership in the Society numbered 289.

Mr. Kenneth Neill, Manager of Gunston Hall, gave a short talk on George Mason and Gunston Hall.

Meeting of November 13, 1964

The Society met at the Hume School Historical Museum, 1805 South Arlington Ridge Road.

It was announced that the Directors had decided to reprint the Society's Special Publication No. 1, "Why Do We Call It . . .?". The need for more copies resulted from two exhibits displayed by the Society during the year.

The 1964 edition of the Arlington Historical Magazine, Vol. 2, No. 4, was published in October and available for purchase at the meeting.

Membership in the Society was reported at 295.

Colonel John V. Hinkel, author of Arlington: Home of Heroes, talked on "The Little Known History of Arlington National Cemetery" illustrated by slides.

Meeting of January 8, 1965

The Society met at the Hume School Historical Museum.

The President announced that the Directors had accepted the invitation of the Arlington Citizen Participation Council to affiliate with their organization. The President was named to represent the Society at the meetings.

Attendance of visitors to the Museum was reported as 643 from October 1963 to December 1964.

The Treasurer reported a balance of \$47.71 in the Operating Account, \$931.68 in the Savings Account, and \$1,600.00 in the Endowment Fund.

Dr. C. Malcolm Watkins, Curator of Cultural History, Smithsonian Institution, spoke on "Colonial Lighting in the South," illustrating his talk with slides.

Meeting of March 12, 1965

The Society met at the Hume School Historical Museum.

The Amendment to Article I, No. 3 of the By-Laws, increasing the adult dues from \$2.00 to \$2.50 per year, was adopted unanimously.

It was announced that the Trust Instrument for management of the Endowment Fund had been drawn up, was now being revised, and would be presented to the membership for adoption at the May meeting.

An additional sign will be placed on the outside of the Museum Building announcing the visiting hours—"Open Sundays from 2 to 4."

All issues of the Arlington Historical Magazine and copies of the Society's Special Publication #1, "Why Do We Call It . . . ?" formerly stored on the 2nd floor of the Museum have been moved to a newly established Book Room on the 1st floor.

Thomas E. White, Historian of Manassas Battlefield Park, gave a talk on "Manassas Campaign" illustrated by slides. Society member Colonel Roy Brewer showed slides and briefly explained the excavation at Fort Scott.

Meeting of May 14, 1965

The Annual Meeting of the Society was held at the Hume School Historical Museum.

The President announced the publication of rules governing the use of the Hume School Historical Museum by those renting the meeting room.

Thanks were extended to Dow Nida who represented the Society at the County's Beautification Program meeting and to Walter Bell who attended the meeting of, the Planning Commission with regard to the preservation of Prospect Hill.

It was reported that the Society's finances as of May 1 reflected a balance in the Operating Fund of \$331.84; in the Savings Account as of January 1, the balance was \$931.68 with accrued interest to be added; in the Endowment Fund, there was \$1,799.38.

Harrison Mann summarized and explained the purpose of the Trust Instrument for management of the Endowment Fund after which there was discussion from the floor. The Trust Instrument was adopted unanimously.

The Secretary's Annual Report for 1964-65 was read.

Membership in the Society was 284.

It was made known that the Society is planning a Historic Arlington Day to take place on October 9, 1965, the theme of which will be "Forts of Arlington" and will include a tour of a few historical homes.
